## The HGC is designed to reduce Canada's food vulnerability and position the country as a leader in the food revolution

- CV-19 as "wake-up call"
- Canada is highly reliant on open borders and the production yields of foreign entities for fresh produce
- High costs to produce fruits and vegetables out of season
- Berries: popular; trade deficit; valuable and nutritious; innovation "sweet spot"; growing systems transferable to other crops
- A significant opportunity for Canada





The Challenge Statement is a goal, which can be achieved through a variety of approaches

The Homegrown Innovation Challenge asks innovators to "create and deliver a market-ready system to reliably, sustainably and competitively produce berries out of season and at scale in Canada."





# The three-phased HGC runs over the course of six-years, culminating with two \$1M prizes in 2028

Shepherd Phase	December 20, 2022*	March 2023	\$1,000,000	10	18 months

#### Inclusion criteria

- Growing system is transferable to other fruits and vegetables
- Culturally and/or culinarily important to Canada

#### **Exclusion criteria**

- Fruit borne of annual plants
- Fruit borne of trees
- Fruit not primarily intended as a food
- Fruit with an atypical growing approach





# Throughout the initiative, we will evaluate grant proposals based on five key criteria; weighting varies, however

4.	Commercial viability	10%	15%	20%	25%	Pass / Fail Solution or components must be market-ready and have a commercial model in place
5.	Environmental sustainability	15%	15%	20%	20%	Pass / Fail Solution must not create an adverse environmental impact
6.	Need for Spark Award (only for Spark Phase)	25%	0%	0%	0%	0%
